# GMS contract changes 25/26

Rashida gave a quick outline of the GMS 25/26 contract changes. Rashida explained that all GP surgeries work against a core GP contract and this year there has been quite a few changes. For example, changes in QOF targets, a lot of the indicators have now been removed, we still must do the work but won't be paid for the indicators that have been removed. More ARRS funding which can be used on newly qualified GP'S and other PCN roles, new enhanced service for advice and guidance (which is basically a pre referral), increased funding on immunisation.
